1. Administration Update:

A. Updates to website

- Website has been updated

B. Building Access

- A lot of keys to the facility are floating around and no record of who has access to the clubhouse. Agreed all board members, commissioners, camp, and Moyer should have keys. All commissioners will keep access to all sheds on property, but share codes/keys with the board.
- Camera - Michelle is working on a quote for 2 cameras on the clubhouse that will have night vision and provide a full view around the facility, they will cost around \$600, quote to follow. One camera would be at the front of the building, the corner at the parking lot, the other would be in the back of the building at the corner by the pavilion and soccer fields to cover the fields and the overflow lot. All cameras would be hardwired in. It was asked if we could have access to view the footage on someone's phone to alert of any issues, also are we liable to show anyone the video if asked.

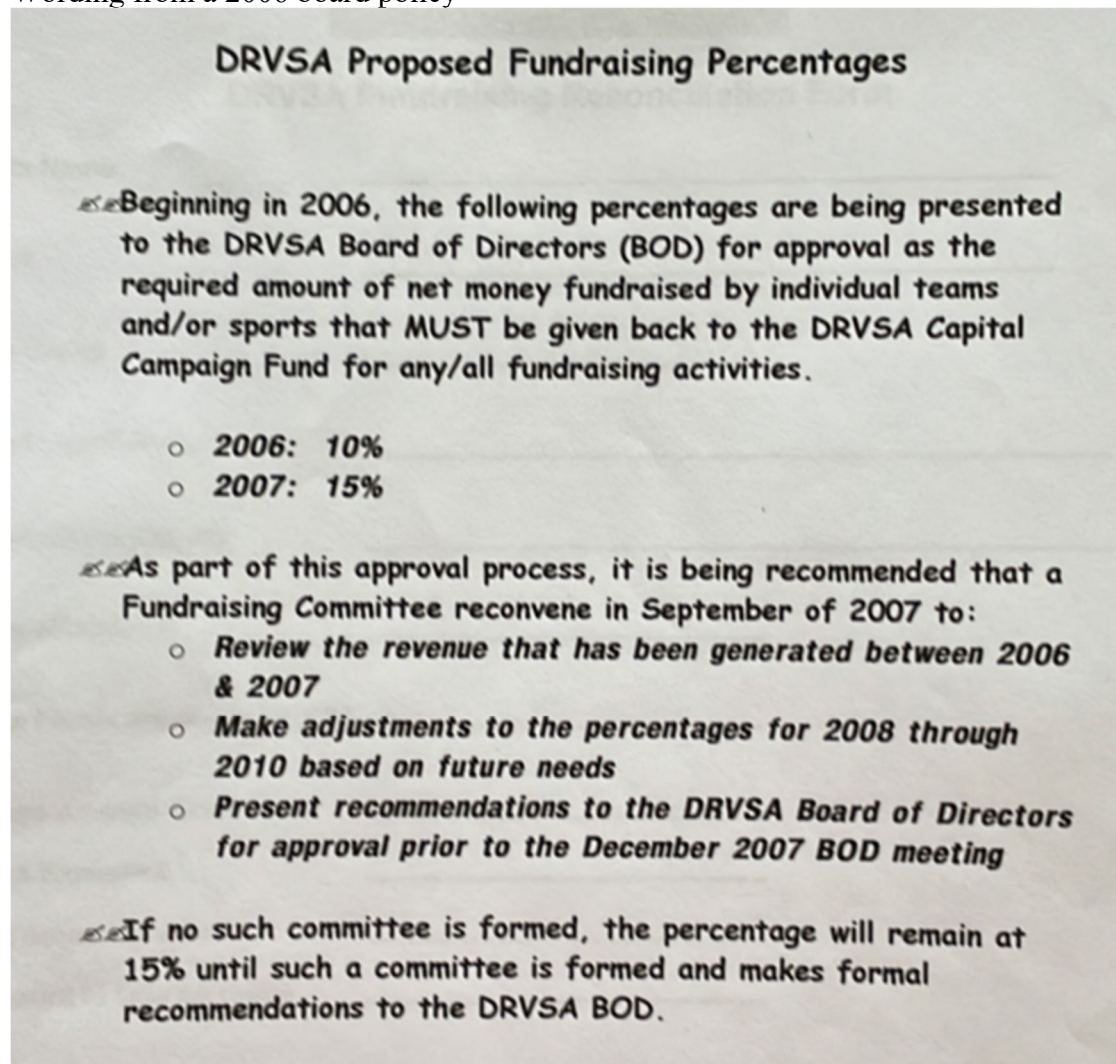
C. Background Checks

- Background checks and concussion protocol training, we have switched systems, Morgan and Michelle will take this over starting in the spring to ensure we have all coaches and volunteers info and it's up to date in the Deep Run system. We do

not want hard copies, can not add to sports engine, we need to manually check. Michelle will check the database for an easier way to enter into the system.

D. Fundraising Policy, Sponsorship Monies, & Tournament Fees

- Proposed that things that impact the club like Field of Dreams tournament, Turkey tournament, ect 10-15% should be given back to the club for use of the snack stand etc,
- Sponsorship - proposed 15% of that should go to the clubs capital fund which benefits every sport. there will be a list of “club sponsors” for individual sports to not approach for more donations. A list needs to be updated and created. Encourage all sports to really go out in the community and recruit new sponsors.

E. Check Writing/Expense Policy

- Too many hands in the cookie jar, the board and Michelle agreed that invoices outside of the routine bills that come into the club need approval by the board before being paid.
- We need a universal policy regarding expenses and how they are paid.
- Possibly creating purchase orders to be submitted to have checks issued to streamline the process and loop the club in.

2. **Financial Update:**

A. **Budget 2022 Draft Review**

- Budget presented to the group, changes were made to the budget combining lines, expenses for wages and salary and payroll expenses.
- Processing fees will be passed to each sport giving an extra \$5 per player to that fee for the club.

Treasurer's report: *(Michelle Boggle for Chris Levush)*

- Jim asked when monies the club borrowed during covid would be repaid to individual sports. Michelle answered that the club is hoping to start paying back in the spring, but it will take time for full reimbursement.  - Soliciting someone to help make some tweaks and improvements to the fields.

Travel Soccer: *(Audrey)*

- Has money in a fund that is up for grabs she can give to intramural to help purchase nets and supplies etc.
- Confirmed with Mark and Sarah which fields they would be using for scheduling conflicts, does not want to interfere with lacrosse. (girls using telegraph and boys @ DR)

Baseball: *(Ryan Alderfer)*

- Phantoms Hockey fundraiser will be taking place Sunday 1/16, with Deep Run hosting the "chuck a puck" fundraiser
- 4/9 is the planned opening day for baseball and softball, a committee has been formed to help plan.
- Phillies day will be the day after closing day for Deep Run and will include softball also. \$4 from every ticket will go back to Deep Run Baseball/Softball.
- Some coaches are uncomfortable entering info into another system for background checks, Michelle relayed it is for insurance purposes and needs to be done.

- Has a coach interested in starting a 10u select team.
- Working with baseball to get softball organized and restructured.

- working on getting umpires
- looking to expand board specifically field maintenance and scheduling

Summer Camp: *(Audrey & Michelle)*

- Last year they sold out with over 300 campers with an extensive waitlist.
- Will be adding more stations and groups this year to accommodate more campers.
- Already getting emails about the start of camp and registering. Camp is waiting for spring registration to take place before they get theirs started.
- Camp has their own social media, facebook and instagram.
- To cut costs a bit they are cutting out snacks they previously provided and passing their credit card processing fees to the family.
